



# Ticket Search Lite User Guide

This Ticket Search feature is readily available to members with RMAA, RMAF, RMAL, RMAP, and RMAS accounts. Go to [tsl.missdig.org](http://tsl.missdig.org) and enter your RMA account credentials.

Unlike long-term Ticket Search, this web-based feature does not require a download of executable software onto your computer. It allows users to search dig and design tickets that were transmitted to their codes during a maximum period of seven days. It will search a specified date range up to 120 days old.
