Placing Short Notice Requests

What is a Short Notice Request and what are the requirements surrounding it? Those are common questions we are asked from both sides of the equation, facility owners and excavators.

Let's start with what a Short Notice request is defined as. A Short Notice Request is a non-

emergency ticket that is placed by an excavator that does not give the facility owners at least a three working day notice. We are asked, "Why do you allow them to place tickets without three working day notice when it says in PA 174 that they must give that notice?" The answer to that question is we don't ever want to turn down someone placing a ticket. If they place the ticket at least the facility owners in the area know that there is a planned excavation and know the location.

A Short Notice Request is placed when the excavator, or a MISS DIG 811 NSR (Notification System Representative), enters a date in the Begin Date field of our Ticket Entry platform that is less then three full working days. This automatically triggers a statement to come up for a RTE (Remote Ticket Entry) user to read or the NSR to read to the caller. This statement says, "State Law requires utilities three working days to locate their lines, so actually they have until" and gives the date and time the facility owners have until to mark their lines.

Along with this, when the excavator who placed a Short Notice Request looks at Positive Response there is a statement that says, "If Your work date is before the response due date you are in violation of Public Act 174 of 2013." When a short notice is placed the Response Due Date and Begin Date will be different. Even though the Begin Date reflects the requested date, the Response Due Date is the actual legal date and time the facility owners have to respond by.

As a locator, make sure you are checking the Response Due Date on the tickets you receive. Just because the Begin Date reflects a Short Notice Request, doesn't mean you legally have to mark it by that date. We get questions from locators asking why we are allowing Emergency Request to be placed where the work type does not meet the definition of an emergency in PA 174. In many of these cases, it is a Short Notice Request, not an Emergency. Some facilities have internal policies mandating that their locators mark any Short Notice Request by the requested Begin Date, in those cases

we can not control what you are required to do.

As indicated above, there is no reason that someone who places a Short Notice Request should be unaware that the facility owners still have the three full working days to respond by. For the locators, it is very simple to check if a ticket is Short Notice Request or an Emergency Request by checking the Response Due Date.
