

## GOLD SHOVEL ASSOCIATION 2019 YEAR IN REVIEW





"This past year has been an eventful one for Gold Shovel. I started working with the association in January 2019 to help re-organize and realign the organization overall." Cheryl Campbell

In keeping with our stated mission of reducing damages to underground infrastructure, we moved forward collaboratively with key stakeholders and committees on a number of fronts. Gold Shovel released DPIR metrics in 2019, providing a consistent and transparent metric for facility owners and excavators to measure damages. Our members' initial results are very promising. Facility owners, contractors, and municipalities that are furthest along in adopting and using the program are seeing significant reductions in damages. Some larger contractors are seeing benefits beyond damage reduction, stating that the program is making them better companies.

We also made progress in the pre-excavation process, which is complex and involves numerous stakeholders. The committee charged with developing this arena has done an

excellent job, producing not only some proposed measures but also in defining certification. You can expect a pilot phase in early 2020 that will bring together locate and mark, excavators, and facility owners to improve the process.

Finally, we're excited about the 16% overall growth we experienced in 2019, and the 40% growth in the utility sector.

Thank you for being part of a collaborative industry solution to reducing damages. With your participation and input, we're looking forward to additional progress in 2020!
